Sub: Intimation of partial commencement of operations at some Manufacturing Plants of the Company.

We refer our letter ref. no. SH/13/2020, dated 25th March, 2020, wherein we had informed temporary suspension of operations at all manufacturing facilities, depots and offices due to Novel Coronavirus pandemic (COVID19).

We wish to inform that Government of India, State Governments, Union Territories and District Administrations, have allowed selective relaxation for commencement of operations in non-containment areas, subject to compliance with certain guidelines.

Accordingly, we have to state that, 15 units of the Company have commenced partial operations out of 25 units in compliance with the permission received from respective authorities. The units where partial operations have commenced are as under:


